RESOLUTION NO. 97-512

WHEREAS, in Resolution No.96-460, the Tohono O'odham Nation Legislative Council accepted USEPA funding under the grant entitled Air Quality Project - Section 103 X 999437-01-0, and authorized expenditure of funds from this grant; and

WHEREAS, the original period of this Project ran from December 10, 1996 to November 30, 1997; and

WHEREAS, on November 25, 1997, a request for an extension was made because the position of Air Quality Specialist had not yet been filled, and the project had not been started yet; and

WHEREAS, on November 25, 1997 the USEPA offered the Nation at no cost extension, entitled Assistance Amendment No. 1, that extends the grant period to November 30, 1998.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts Assistance Amendment No. 1 to Air Quality Project 103 X 999437-01-0, extending the grant period to November 30, 1998

BE IT FURTHER RESOLVED by the Tohono O'odham Nation Legislative Council that the Tohono O'odham Nation's Officials, to wit: the Chairman, Vice Chairman and any designated official are hereby authorized to negotiate and execute this grant as amended, provided however, that any amendments affecting the funding or funding

16 of the Act of June 18, 1934 (48 Stat. 984).**
