WHEREAS, the Tohono O'odham Legislative Council is charged with the responsibility of supporting and promoting quality educational programs for all Tohono O'odham; and

WHEREAS, the Tohono O'odham Education Department/Venito Garcia Library was awarded \$20,000.00 from the State LSCA Title II with matching funds in the amount of \$20,000.00 from the Tohono O'odham Nation; and

WHEREAS, the State LSCA's contribution will be utilized specifically for purchase of capital equipment and building alterations and renovations.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council fully supports the Venito Garcia Library Services Construction/Enhancement FY 97 LSCA Title grant award in the amount of \$20,000.00.

BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's Officials, to wit: the Chairman and any designated official are hereby authorized to execute the grant application, provided however, that any amendments affecting the funding or funding levels of this grant shall be submitted for further approval.
