**WHEREAS, the Job Training Partnership Act was awarded a base budget for
fiscal year beginning July 1, 1997 and ending June 30, 1998 in the
amount of \$448, 197.00; and**

**WHEREAS, an analysis of carry overs determined that there is an unspent
balance of \$829,321.00 from program years 1994, 1995, and 1996;
and**

**WHEREAS, the program has presented a budget modification #1 to the
Administrative Cost Pool increasing the total budget amount from
\$89,639.00 to \$255,504.00; and**

**WHEREAS, the program has presented a budget modification #2 to Program
increasing the total training budget from \$237,996.00 to
\$638,759.00, increasing the total employment costs budget from
\$41,591.00 to \$154,872.00, and increasing the total support
services budget from \$78,971.00 to \$228,383.00.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
Council that it hereby approves the JTPA Title IV A DOL Budget
Modification #1 - ACP and Budget Modification #2 - Program for a
total revised Title IV A DOL budget amount is \$1,277,518.00.**

**BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
that the Tohono O'odham Nation's Officials, to wit: the Chairman
and any designated official are hereby authorized to negotiate
and execute the contract, provided however, that any**

amendments affecting the funding or funding levels of this contract shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'odham Council on the 12TH day of DECEMBER, 1997 at a meeting at which a quorum was present with a vote of 1,738.0 OR; -0- AGAINST; -0- NOT VOTING; and 189.0 [06] ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


