

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adopting the Executive Branch's Initiative Administrative Budget
Supplemental Request for the Tohono O'odham Enrollment Office
in the Amount of \$48,873.19)**

RESOLUTION NO. 97-519

WHEREAS, on June 23, 1997, Initiative IN-01-97, *O'odham Voice on Use of Gaming Revenues*, was enacted into law by the registered voters of the Tohono O'odham Nation; and

WHEREAS, the Initiative appropriates and authorizes a \$2,000 per capita distribution of the Nation's Gaming revenues to each eligible enrolled member of the Nation; and

WHEREAS, the Tohono O'odham Enrollment Office has been directed by Executive Order 97-001 with creating a system of tracking the membership of the Nation to provide accurate information to the Accounting Department for the purposes of accurate distribution of per capita payments; and

WHEREAS, the Executive Branch requested and received an appropriation of \$88,839.07 to enable the Enrollment Office to determine eligibility and prepare for a per capita distribution; and

WHEREAS, the Enrollment Office has advised the Office of the Chairman of the need for an additional appropriation to provide for the cost of continuing activities required for verifying and establishing the per capita distribution roll; and

WHEREAS, the Enrollment Office did prepare and present a Supplemental Request, attached and incorporated into this resolution; and

WHEREAS, the Executive Office of the Chairman recommends approval of this Supplemental Budget request; and

WHEREAS, the Legislative Council did by Resolution #97-478, *Establishing Set-aside Accounts at Bank of America for Initiative Measures*, allocate \$1,800,000 to provide for the administrative cost of implementing the provisions of Initiative IN-01-97.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the attached *Executive Branch FY 1998 Initiative Administrative Supplemental Budget Request, Tohono O'odham Enrollment Office* is hereby approved and the Executive Branch is hereby authorized to expend according to the budget.

BE IT FURTHER RESOLVED that the funds requested, \$48,873.19, be appropriated from the Initiative Administrative Costs set-aside account.

The foregoing Resolution was passed by the Tohono O'odham Council on the 12TH day of DECEMBER, 1997 at a meeting at which a quorum was present with a vote of 1.657.5 OR; -0- AGAINST; 80.5 NOT VOTING; and 189.0 [06] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2) Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
