**WHEREAS, the Legislative Council had decided that the amount of \$500.00, be given to each employee without tax deductions; and**

**BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council does hereby approve and appropriate a total amount of \$534,240.00 from the General Account to provide for Christmas Bonus payments.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 12TH day of DECEMBER, 1997 at a meeting at which a quorum was present with a vote of 803.0 OR; 623.0 AGAINST; 312.0 NOT VOTING; and 189.0 [06] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
