(Appropriating \$37,255.00 for the Tohono O'odham Population  
and Housing Survey Budget)**

**RESOLUTION NO. 98-011**

**WHEREAS, by Resolution No. 97-235, the Tohono O'odham Legislative Council appropriated \$100,000.00 to conduct a Population and Housing Survey; and**

**WHEREAS, the FY97 Tohono O'odham Population and Housing Survey Budget included the operational costs and surveyor's salaries; and**

**WHEREAS, additional appropriations is being requested to provide for the continued operation and finalization of the Population and Housing Survey; and**

**WHEREAS, the Legislative Housing Committee recommends for approval.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes the appropriation in the amount of \$37,255.00 to be expended from the General Revenue Account to complete the Tohono O'odham Population and Housing Survey.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 9TH, day of JANUARY, 1998 at a meeting at which a quorum was present with a vote of 1,296.5 OR; 382.0 AGAINST; 248.5 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
