

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Override Vetoes Resolution No. 98-008, Adoption of the Executive Branch
Supplement Budget for Fiscal Year 1998)**

FAILED

RESOLUTION NO. 98-022

WHEREAS, during the January 8, 1998 General Session of the Tohono O'odham Legislative Council, the Legislative Council did pass Resolution No. 98-008; and

WHEREAS, upon presentation of Resolution 98-008 to the Chairman of the Tohono O'odham Nation, he did disapprove thereof and returned it to the Council with his objections in accordance with the provisions of Article VII, Section 5 of the Constitution of the Tohono O'odham Nation; and

WHEREAS, during the January 23, 1998 Legislative Session, the Chairman of the Nation presented his justifications in vetoing Resolution 98-008 (a copy of which is hereto attached); and

WHEREAS, the Tohono O'odham Legislative Council has reviewed the Chairman's objections and after consideration, again voted to pass Resolution No. 98-008.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby override the Chairman's veto by a vote of two-thirds of the votes cast.

The foregoing Resolution was presented to the Tohono O'Odham Legislative Council on the 23RD, day of JANUARY, 1998 at a meeting at which a quorum was present and by a vote of 908.5 FOR; 850.5 AGAINST; 168.0 NOT VOTING; and [01] ABSENT, failed to pass because it did not receive a two-thirds (2/3) [1,172.6] of the votes cast as required by Section V of Article VII of the Constitution of the Tohono O'odham Nation.
