

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adoption of the Executive Branch Supplement Budget for Fiscal Year 1998)**

RESOLUTION NO. 98-023

WHEREAS, the Executive Branch has prepared and presented the Executive Branch Supplement Budget (Supplement Budget) for fiscal year 1998 in the amount of \$2,351,971.17, including \$753,770 for capital purchases and \$211,000 for facility maintenance; and

WHEREAS, Tohono O'odham Legislative Council by Resolution #97-420, *Continuing Authorization for the Tohono O'odham Career Center, Credit and Finance Program, Additional WIC Personnel and General Operations of the Food Distribution Program*, permit the continued operations of these programs pending formal approval of Supplement Budget; and

WHEREAS, the Supplement Budget as presented includes retroactive budgets for programs authorized in Resolution #97-420; and

WHEREAS, the Executive Branch requests the Operational Supplements be made a part of the base funding for the programs identified.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative that the Executive Branch Supplement Budget for fiscal year 1998, in the amount of \$2,351,971.17, including \$753,770 for capital purchases and \$211,000 for facility maintenance is hereby adopted as presented, and is authorized to be expended accordingly.

BE IT FURTHER RESOLVED that the operational portion of the Supplement Budget as appropriated is further authorized to become a part of the base funding for each respective program.






