

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Override Vetoed Resolution No. 98-030, Appropriating and Identifying
Funding for the Tohono O'odham Fire Department from IC-002)**

RESOLUTION NO. 98-032

**WHEREAS, during the January 23, 1998 Special Session of the Tohono O'odham
Legislative Council, the Legislative Council did pass Resolution No.
98-030; and**

**WHEREAS, upon presentation of Resolution 98-030 to the Chairman of the
Tohono O'odham Nation, he did disapprove thereof and returned
it to the Council with his objections in accordance with the
provisions of Article VII, Section 5 of the Constitution of the Tohono
O'odham Nation; and**

**WHEREAS, during the February 9, 1998 Legislative Session, the Chairman of
the Nation presented his justifications in vetoing Resolution 98-030
(a copy of which is hereto attached); and**

**WHEREAS, the Tohono O'odham Legislative Council has reviewed the
Chairman's objections and after consideration, again voted to pass
Resolution No. 98-030.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
Council does hereby override the Chairman's veto by a majority of
two-thirds of the votes cast.**

**The foregoing Resolution was presented to the Tohono O'Odham Legislative
Council on the 9TH, day of FEBRUARY, 1998 at a meeting at which a quorum was
present and by a vote of 1,309.5 FOR; 617.5 AGAINST; -0- NOT VOTING; and [04]
ABSENT, was passed by a majority of two-thirds (2/3) [1,284.7] of the votes cast as
required by Section 5 of Article VII of the Constitution of the Tohono O'odham
Nation.**


