1 $\mathbf{2}$ RESOLUTION NO. 98-032 3 WHEREAS. during the January 23, 1998 Special Session of the Tohono O'odham 4 5 Legislative Council, the Legislative Council did pass Resolution No. 6 98-030; and 7 WHEREAS. upon presentation of Resolution 98-030 to the Chairman of the 8 Tohono O'odham Nation, he did disapprove thereof and returned 9 it to the Council with his objections in accordance with the 10 provisions of Article VII, Section 5 of the Constitution of the Tohono 11 O'odham Nation: and 12 WHEREAS, during the February 9, 1998 Legislative Session, the Chairman of 13 the Nation presented his justifications in vetoing Resolution 98-030 14 (a copy of which is hereto attached); and 15 WHEREAS, the Tohono O'odham Legislative Council has reviewed the 16 Chairman's objections and after consideration, again voted to pass 17 18 Resolution No. 98-030. 19 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative 20 Council does hereby override the Chairman's veto by a majority of 21 two-thirds of the votes cast. 22 The foregoing Resolution was presented to the Tohono O'Odham Legislative Council on the 9TH, day of FEBRUARY, 1998 at a meeting at which a quorum was 23 present and by a vote of 1.309.5 FOR; 617.5 AGAINST; -0- NOT VOTING; and [04] 24ABSENT, was passed by a majority of two-thirds (2/3) [1,284.7] of the votes cast as required by Section 5 of Article VII of the Constitution of the Tohono O'odham **25** Nation. 26 TOHONO O'ODHAM LEGISLATIVE COUNCIL 27 28
