(Enrollment - February)**

RESOLUTION NO. 98-034

BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of the Tohono O'odham Nation reduce this final determination in writing regarding each of the foregoing applications for enrollment in accordance with Section 3(c) of Article III of the Enrollment Ordinance; give notice of this Council's determination in accordance with Section 4 of Article III of the Enrollment Ordinance; and place the names of each applicant upon the membership roll of the Tohono O'odham Nation in accordance with Article V of the Enrollment Ordinance.
