

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adoption of the Scholarship FY 98 Supplemental Request and
Appropriating Funds from the Scholarship Set Aside)**

RESOLUTION NO. 98-039

**WHEREAS, the Tohono O'odham Nation has by previous legislation provided a
reserve to fund the administration of the Nation's Scholarship Fund
and educational grants to eligible members; and**

**WHEREAS, the Executive Branch has prepared and presented a FY 98
Supplemental Request for the Scholarship Fund in the amount of
\$ 16,459.53 to establish a new Supervisor's position in the program;
and**

**WHEREAS, sufficient funds remain in the established reserve to fund the
request as presented.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council
that the Fiscal Year 1998 Supplemental Request of the Scholarship
Fund is hereby adopted, and is authorized to be expended
accordingly.**

**BE IT FURTHER RESOLVED that the amount required, \$16,459.53 shall be
appropriated from the established reserves.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the
11TH. day of FEBRUARY 1998 at a meeting at which a quorum was present with
a vote of 1,813.0 FOR; -0- AGAINST; -0- NOT VOTING; and 114.0 [06] ABSENT,
pursuant to the powers vested in the Council by Section 1(d)((2) & (3) of Article VI
of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
O'Odham Nation on January 18, 1986; and approved by the Acting Deputy
Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to
Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


