

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Supporting the Amendments to the Tohono O'odham Nation Scholarship
Fund Application Requirement)**

RESOLUTION NO. 98-040

WHEREAS, the Tohono O'odham Nation Scholarship Fund has presented a change in the scholarship requirements to remove the work obligation requirement, which will be retroactive from Fall Semester 1995 to present; and

WHEREAS, the following wording will be removed: Upon completion of training/education the recipient must seek employment with the Tohono O'odham Nation or any entity providing services to Tohono O'odham. The extent of the recipient obligation to the Nation will be determined by the length of training/education that they receive. The minimum will be one year; and

WHEREAS, the said wording will be deleted from the agreement between the recipient and the Tohono O'odham Nation Scholarship Fund (the Nation); and

WHEREAS, it will also be deleted from the Tohono O'odham Nation Scholarship Fund Policy.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does support and recognize the deletion of the work obligation requirement to the Tohono O'odham Nation Scholarship Fund application requirements.

BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that it approves the Tohono O'odham Nation Scholarship Fund's amendment to the Tohono O'odham Nation Scholarship Fund application requirement.
