17		support not be attained in a timely manner; and
18	WHEREAS,	crop preparation and planting has been implemented for the 1998
19		crop season and funding is crucial in order to continue for the
20		remainder of 1998; and
21	WHEREAS,	the Agriculture and Budget & Finance Committees have agreed in
22	-	principle to support the request for a Letter of Credit, provided that
23		an account be identified for the application of a Letter of Credit.
