

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 1998 Title III and Title VI Donations/Account #14-1424)**

RESOLUTION NO. 98-054

WHEREAS, the Tohono O'odham Nation has successfully operated a program for the elderly members of the Nation; and

WHEREAS, funding for the operation of the Elderly Program has been made possible in part by the Older American's Act of 1965 as amended; and

WHEREAS, the Older American's Act, provides that elders may make donations to the program during the congregate meals and that such donations will be used for program needs; and

WHEREAS, the elders voluntarily made donations between December 1995 to November 1997.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby approve and authorize expenditures in accordance with the attached budget.

BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that donations from elders be put in a fund segregated from the general fund to ensure that the funds are utilized only for the needs of the elderly program.

The foregoing Resolution was passed by the Tohono O'odham Council on the 13TH. day of FEBRUARY, 1998 at a meeting at which a quorum was present with a vote of 1,063.0 FOR; -0- AGAINST; -0- NOT VOTING; and 864.0 [14] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
