Tohono O'odham Department of Human Services - Division of Child  
Welfare Services Program.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative  
Council does hereby approve this amendment and authorizes  
expenditures in accordance with the attached budget.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 13TH,  
day of FEBRUARY, 1998 at a meeting at which a quorum was present with a vote of  
1,435.0 FOR; -0- AGAINST; -0- NOT VOTING; and 492.0 [12] ABSENT, pursuant to the  
powers vested in the Council by Section 1(f) of Article VI of the Constitution of the  
Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18,  
1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
Stat. 984).**
