RESOLUTION NO. 98-058

**WHEREAS, the Tohono O'odham Nation has provided preventive health care for
women, infants and children during Fiscal Year 1998; and**

**WHEREAS, funding for the operation of the Women, Infants and Children (WIC)
has been provided in part through supplemental funding sources;
and**

**WHEREAS, the Division of Community Health Services - Women, Infants, and
Children (WIC) Program is modifying FY 1998 Tribal Base Budget to
decrease and add line item to purchase vehicle for the program; and**

**WHEREAS, a budget modification is submitted for review and approval by the
Department of Human Services, Division of Community Health
Services.**

NOW, THEREFORE, BE IT RESOLVED:

- 1. That the Tohono O'odham Legislative Council hereby approves
the attached budget modification.**
- 2. The Tohono O'odham Nation Officials, to wit: the Chairman and
Vice Chairman and any designated Official are hereby
authorized to negotiate and execute the contract.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the
13TH day of FEBRUARY, 1998 at a meeting at which a quorum was present with
a vote of 1,435.0 FOR; -0- AGAINST; -0- NOT VOTING; and 492.0 [13] ABSENT,
pursuant to the powers vested in the Council by Section 1(d)(3) of Article VI of the
Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham
Nation on January 18, 1986; and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16
of the Act of June 18, 1934 (48 Stat. 984).**
