

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of FY 1998 Women, Infants and Children (WIC) Program
Budget Modification #1)**

RESOLUTION NO. 98-059

WHEREAS, the Tohono O'odham Nation is presently providing preventive health care for women, infants and children; and

WHEREAS, the Inter-Tribal Council of Arizona receives funds from the United States Department of Agriculture for programs designed to benefit women, infants and children; and

WHEREAS, the Tohono O'odham Nation has entered into a Memorandum of Agreement with Inter-Tribal Council of Arizona to fund and operate the Women, Infants and Children (WIC) Program; and

WHEREAS, due to an increase on the ITCA/WIC agreement based on current caseload of 1,000 plus participants, an increase of funding of \$13,140; and

WHEREAS, a budget modification is submitted for review and approval by the Department of Human Services, Divisions of Community Health Services.

NOW, THEREFORE BE IT RESOLVED:

- 1. That the Tohono O'odham Legislative Council hereby approves the attached budget in the amount of \$13,140.**
- 2. The Tohono O'odham Nation Officials, to wit: the Chairman and Vice Chairman and any designated Official are hereby authorized to negotiate and execute the contract.**

The foregoing Resolution was passed by the Tohono O'odham Council on the 13TH, day of FEBRUARY, 1998 at a meeting at which a quorum was present with a vote of 1,596.0 FOR; -0- AGAINST; -0- NOT VOTING; and 331.0 [13] ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


