(Approving the Organization of the Economic Development Department,  
and Approving its FY 1998 Budget)**

**RESOLUTION NO. 98-064**

**WHEREAS, the ballot initiative IN-01-97, known as the "O'odham Voice" was passed into law on June 28, 1997; and**

**WHEREAS, the Initiative establishes an Economic Development Department to perform the day to day work associated with promoting Economic Development for the Tohono O'odham Nation; and**

**WHEREAS, the Initiative directs that all overhead costs of activities related to promoting Economic Development on the Tohono O'odham Nation be paid from Gaming revenues; and**

**WHEREAS, the Legislative Council has set-aside funds as Administrative Costs for Implementation of the Initiative by means of Resolution 97-451 Adopting an Initiative Funding and Implementation Plan; and**

**WHEREAS, Executive Order 97-004 orders the Economic Development Task Force and the Credit and Finance Program to identify the administrative and budget requirements necessary for implementing provisions of the Initiative; and**

**WHEREAS, the Economic Development Task Force and the Credit and Finance Program have done so, and submitted the attached documents titled "Budget Form 2", and "Budget Form 2A", "Budget Form 2B", and "Budget Form 2C"; and**

**WHEREAS, the Executive Branch has reviewed these documents, and approved the organization, activities, and budget proposed for the Economic Development Department; and**

**WHEREAS, these documents have been submitted to the Legislative Budget and Finance Committee and the Legislative Commerce Committee; and**

**WHEREAS, the Initiative Funding and Implementation Plan requires that expenditures of funds in the Initiative — Administrative Costs account is subject to approval by the Legislative Council of budgets for fiscal year 1998.**

**NOW, THEREFORE, BE IT RESOLVED by the Legislative Council of the Tohono O'odham Nation that the Economic Development Department of the Executive Branch is authorized to expend funds pursuant to the attached from the set-aside created by the Legislative Council as Administrative Costs for Implementation of the Initiative.**

**BE IT FURTHER RESOLVED THAT the Chairman of the Tohono O'odham Nation is authorized to negotiate and enter into contracts or Intergovernmental Agreements for the educational, training, or other services specified in this budget.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 18TH day of FEBRUARY, 1998 at a meeting at which a quorum was present with a vote of 1,652.0 FOR; -0- AGAINST; -0- NOT VOTING; and 275.0 [08] ABSENT, pursuant to the powers vested in the Council by Section 1(d) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


