

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Appropriating Funds for the Hia-Ced O'odham Alliance)**

**RESOLUTION NO. 98-065**

**WHEREAS, the Hia-Ced O'odham Alliance had numerous meetings with the Tohono O'odham Legislative Domestic Affairs Committee and Hia-Ced O'odham Advisory Board regarding the Hia-Ced O'odham; and**

**WHEREAS, one of the topics discussed was the hardship of funeral services at Darby Wells with regards to digging graves at the Darby Wells Cemetery, and**

**WHEREAS, the Hia-Ced O'odham Alliance has proposed a budget for the purchase of much needed equipment for use in digging graves at the Darby Wells Cemetery, and**

**WHEREAS, the Domestic Affairs and Budget & Finance Committee did review the proposal and recommend for approval.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby appropriates \$12,555.00 for equipment purchase and that the funding amount be appropriated from the FY 1997 identified savings.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 18TH day of FEBRUARY, 1998 at a meeting at which a quorum was present with a vote of 1,519.0 FOR; 174.0 AGAINST; 73.0 NOT VOTING; and 161.0 [07] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
