**RESOLUTION NO. 98-080**

**WHEREAS, Legislative Order No. 138-90 created the Appropriations Committee as  
a standing committee of the Legislative Council to follow up on the  
Federal Congressional Appropriations process and the Nation's  
priorities; and**

**WHEREAS, the Legislative Council Appropriations Committee has solicited and  
received from the Nation's programs and departments various  
proposed funding requests for FY 98 Federal Appropriations; and**

**WHEREAS, funding requests will be submitted to the appropriate Congressional  
committees, representatives, and federal agencies in Washington, D.C.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council  
does hereby authorize the Appropriations Committee to testify and  
lobby on behalf of the Tohono O'odham Nation for FY 1999  
appropriations funding requests.**

**BE IT FURTHER RESOLVED that the Appropriations Committee shall submit a  
report to the Tohono O'odham Legislative Council upon their return.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 23RD,  
day of FEBRUARY, 1998 at a meeting at which a quorum was present with a vote of  
1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers  
vested in the Council by Section 1 (j) of Article VI of the Constitution of the Tohono  
O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and  
approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on  
March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
