8		measures, including a one-time per capita distribution of \$2,000 to
9		each member of the Nation enrolled on June 28, 1997 (the "Initial Per
10		Capita Distribution"); and
11	WHEREAS,	pursuant to Resolution 97-451, the Legislative Council adopted an
12		Initiative Funding and Implementation Plan (the "FIP") which
13		authorized the establishment of set-aside accounts for the Initial Per
14 15		Capita Distribution and other Initiative measures, and set certain
16		conditions on the expenditure of funds from such accounts; and
17	WHEREAS,	by Resolution 97-478, the Legislative Council approved the transfer of
18		funds from the Desert Diamond Savings Account to certain designated
19		set-aside accounts established at Bank of America Arizona, including
20		the sum of \$41.5 million to set-aside account no. 3030425-1067524 for
21		the Initial Per Capita Distribution (the "Per Capita Account"); and
22	WHEREAS,	three of the conditions to expenditure of the Per Capita Account
23		specified in the FIP are (1) approval by the Secretary of the Interior of
24		a per capita distribution plan (the "Revenue Allocation Plan")
25		pursuant to the requirements of the Indian Gaming Regulatory Act, 25
26		U.S.C. § 2710 (b) (3); (2) acceptance by the Legislative Council of a
27		Certification of Eligible Members submitted by the Enrollment Office

WHEREAS, all conditions under the laws of the United States and the Nation have been satisfied to permit the disbursement of the Initial Per Capita Distribution to the members listed in the Certification of Eligible members.

NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. The Tohono O'odham Legislative Council hereby accepts and approves the Certification of Eligible Members, in the form attached hereto.
- 2. The Legislative Council authorizes (a) the transfer of the sum of \$270,000 from the Per Capita Account to the special checking account no. 252-350-324 established at Bank of America Arizona (the "Per Capita Checking Account"); and (b) upon the joint signature of the Chairman and Vice Chairman of the Nation, issuance of a check on the Per Capita Checking Account in the amount of (i) \$2,000 to each Eligible Member who is a resident or citizen of the United States and is listed in the attached Certification of Eligible Members and (ii) \$1,400 to each Eligible Member who is not a resident or citizen of the United States and is listed in the attached Certification, with the balance of \$600 withheld and remitted to the Internal Revenue Service pursuant to the requirements of federal law.
- 3. The Chairman of the Nation is authorized to execute such other documents as may be necessary to implement this Resolution.
