WHEREAS, the Advocate Program has presented a contract for Donnelly A. Dybus which confirms and ratifies the terms and conditions related to future services, a copy of which is attached; and

WHEREAS, the Domestic Affairs Committee recommends approval by the Legislative Council of an Attorney Contract with Donnelly A. Dybus on such terms.
