

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Tohono O'odham Utility Authority Right-of-Way, San Xavier
Community, San Xavier District, Tohono O'odham Nation)**

RESOLUTION NO. 98-090

WHEREAS, by Resolution No. 08-70 the Nation established the Papago Tribal Utility Authority, now known as Tohono O'odham Utility Authority (TOUA), for purposes of constructing, maintaining and operating various utility systems within the Nation to be owned wholly by the Nation; and

WHEREAS, the Tohono O'odham Legislative Council on 10 December 1990 did pass Resolution No. 447-90 (Amending the Restated Plan of Operation of the Tohono O'odham Utility Authority) which requires the Authority to submit for prior review and approval of the Legislative Council and each affected District any proposed utility easement; and

WHEREAS, TOUA requests permission for a Right-of-Way to extend the Water System within San Xavier Community, San Xavier District, Tohono O'odham Nation; and

WHEREAS, TOUA has respectfully submitted all documents and pertinent information (attached hereto and incorporated herein by reference) for uses consistent with the authorized purposes of TOUA; and

WHEREAS, the San Xavier District has determined that the location of the requested Right-of Way is not in conflict with any land use plans adopted by the San Xavier Community, San Xavier District and approved by the Tohono O'odham Legislative Council; and

WHEREAS, the San Xavier District Council approved the requested Right-of-Way by its District Council Resolution No. 06-97-13.



NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby approve the Right-of-Way as requested by TOUA to extend the existing water system for the location (as more fully described in the attached map and legal description) and construction by TOUA for uses consistent with the authorized purposes of TOUA.

The foregoing Resolution was passed by the Tohono O'odham Council on the 3RD, day of MARCH, 1998 at a meeting at which a quorum was present with a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1 (i) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
