**WHEREAS, the Tohono O'odham Legislative Council has established the Tohono
O'odham Fire Department to serve the Nation in all areas of fire
protection; and**

**WHEREAS, the Tohono O'odham Nation Fire Department's supplemental budget
request is hereby presented in the amount of \$745,618.00 per the
directive in Resolution No. 98-030; and**

**WHEREAS, the Tohono O'odham Fire Department has presented the budget before
the appropriate committees following the established budget process;
and**

**WHEREAS, the Tohono O'odham Fire Department is hereby requesting that the
supplemental budget of \$745,618.00 be approved and be included as part
of the FY-98 base budget of which the amount is \$756,518.92 for the Fire
Department; this will bring the total amount of funds to be utilized as the
base budget \$1,592,236.00; and**

**WHEREAS, the Commerce and Budget & Finance Committee of the Legislative
Council recommends the approval of the inclusion of the FY98
Supplemental Budget to the FY98 base budget for the Tohono O'odham
Nation Fire Department.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council
hereby approves the addition of the supplemental FY98 budget to the
FY98 base budget of the Tohono O'odham Nation Fire Department.**

**The foregoing Resolution was presented to the Tohono O'Odham Legislative Council
on the 6TH, day of MARCH, 1998 at a meeting at which a quorum was present, and by
a vote of 647.5 FOR; 856.5 AGAINST; 73.0 NOT VOTING; and 350.0 [10] ABSENT, failed to
pass because it did not receive a majority of the votes cast as required by Section 2 of
Article V of the Constitution of the Tohono O'odham Nation.**
