**RESOLUTION NO. 98-101**

**WHEREAS, the Tohono O'odham Election Board has received the following petitions from concerned members of San Xavier District for the recall of the following San Xavier District Council Officials:**

**WHEREAS, the Election Board did submit the Recall Petitions and the Certification of the Recall Petitions to the Legislative Secretary on March 5, 1998; and**

**WHEREAS, the Election Ordinance of the Tohono O'odham Nation, by Section 13, Article X, cites the responsibility of the Tohono O'odham Legislative Council to establish a Special Recall date within 40 days.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council has hereby established the date of April 11, 1998 to conduct in San Xavier District, the Special Recall Election of Philbert Bailey, Ella Begay, Janice Felix, and Joanne Preston.**

**BE IT FURTHER RESOLVED that the Tohono O'odham Election Board will be responsible to conduct the Special Recall Election.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 6TH day of MARCH, 1998 at a meeting at which a quorum was present with a vote of 1,738.0 FOR; -0- AGAINST; -0- NOT VOTING; and 189.0 [10] ABSENT, pursuant to the powers vested in the Council by Section 1 (g) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**




