

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Acceptance of the 1997 ICDBG Grant from the Federal Department of
Housing and Urban Development for Housing Rehabilitation, and
Authority to expend Funds)**

RESOLUTION NO. 98-108

WHEREAS, as Tohono O'odham Nation is committed to improving housing conditions on the Nation;

WHEREAS, the Tohono O'odham Nation recognizes that one effective way to ensure the improvement of housing resources on the Nation is to pursue and use grant funds for housing rehabilitation under the Department of Housing and Urban Development's Indian Community Development Block Grant program; and

WHEREAS, the Nation applied for and received full funding under the 1997 ICDBG funding cycle in the amount of \$1,976,695.00; and

WHEREAS, the Legislative Council approved, in Resolution No. 97-296, the submission of a grant application to the Federal Department of Housing and Urban Development under the ICDBG program; and

WHEREAS, DHUD has awarded funds in the amount of \$1,976,695.00 to the Nation for this purpose.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the expenditure of funds from this grant from DHUD for the purposes of Housing Rehabilitation.

BE IT FURTHER RESOLVED that the responsibility and authority to implement these grant funded projects lies with the Executive Branch through its Planning and Economic Development Department and ICDBG Program Office.




