

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of FY 1999 Elderly Title VI Program Grant Proposal)**

RESOLUTION NO. 98-114

WHEREAS, the Tohono O'odham Nation has successfully operated a program for the elderly members of the Nation; and

WHEREAS, funding for the operation of the Elderly Program has been possible in part by Title VI of the Older American's Act of 1965, as amended; and

WHEREAS, the Elderly Program is requesting continuation of the Administration of Aging Title VI grant in the amount of \$82,080.00.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:


- 1. It does hereby approve the proposal for continued funding of the Title VI Elderly Program to provide services to eligible members of the Tohono O'odham Nation.**
- 2. The term of this grant shall commence on April 01, 1998 and end on March 31, 1999.**
- 3. The Tohono O'odham Nation's officials, to wit; the Chairman and any designated official are hereby authorized to negotiate and execute the grant.**

The foregoing Resolution was passed by the Tohono O'odham Council on the 18TH day of MARCH, 1998 at a meeting at which a quorum was present with a vote of 1,738.0 FOR; -0- AGAINST; -0- NOT VOTING; and 189.0 [04] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


