RESOLUTION NO. 98-115

WHEREAS, the Tohono O'odham Nation is presently operating the Department of Human Services - Division of Family Assistance/Child Welfare and Children's Home Program under FY 1998, P.L. 93-638 contract with the Bureau of Indian Affairs; and

WHEREAS, any amendments affecting the funding or funding levels of the contract shall be submitted for review and approval by the Tohono O'odham Legislative Council; and

WHEREAS, two temporary Group Home Worker positions will be filled immediately with employment ending September 30, 1998; and

WHEREAS, an amendment has been submitted for review and approval by the Department of Human Services - Family Assistance/Child Welfare and Children's Home Program.

NOW, THEREFORE BE IT RESOLVED THAT:

- 1. The Tohono O'odham Legislative Council authorizes the expenditures of these funds according to the attached budget modifications for the following programs: from Family Assistance/Child Welfare to Children's Home Program.**

The foregoing Resolution was passed by the Tohono O'odham Council on the 18TH day of MARCH, 1998 at a meeting at which a quorum was present with a vote of 1,738.0 FOR; -0- AGAINST; -0- NOT VOTING; and 189.0 [04] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


