

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Ratifying the Professional Services Contract Between Demott Business
Systems and the Tohono O'odham Nation and Approving
Addendum No. 2)**

RESOLUTION NO. 98-117

WHEREAS, the Tohono O'Odham Legislative Council is satisfied with the performance of Demott Business Systems, Inc., and, therefore, wishes to continue a contractual relationship with Demott Business Systems through Fiscal Year 1998; and

WHEREAS, the Tohono O'Odham Nation has present and anticipated equipment and services needs during the balance of Fiscal Year 1998; and

WHEREAS, Budget and Finance reviewed and recommends approval to Addendum No. 2 and the contract amount be increased by \$28,000.00 for equipment and related services from Account No. 01-1002-750, and the contract term be extended to September 30, 1998.

NOW, THEREFORE, BE IT RESOLVED THAT the Tohono O'Odham Legislative Council hereby approves Addendum No. 2 as appended hereto, to the Contract between the Tohono O'Odham Nation and Demott Business Systems, Inc. and authorizes the Chairman to execute Addendum No. 2

BE IT FINALLY RESOLVED that the Tohono O'Odham Legislative Council authorizes the Chairman of the Nation and the Chairman of the Legislative Council to sign the Addendum.

The foregoing Resolution was passed by the Tohono O'odham Council on the 18TH day of MARCH, 1998 at a meeting at which a quorum was present with a vote of 1,738.0 FOR; -0- AGAINST; -0- NOT VOTING; and 189.0 [04] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
