4 **WHEREAS, Section 1(a) of Article II of the Constitution of the Tohono O'odham**
5 **Nation provides that the Tohono O'odham Council can make additions**
6 **and changes to the official census rolls of the Sells and Gila Bend**
7 **Reservations dated January 1, 1937 and of the San Xavier Reservation**
8 **dated January 1, 1940, subject to the approval of the Secretary of the**
9 **Interior; and**

11 **WHEREAS, the Enrollment Committee has determined that the following named**
12 **person(s) was a member of the Tohono O'odham Nation on the date of**
13 **the respective census rolls but that their name(s) had been**
14 **inadvertently omitted therefrom, and had recommended that their**
15 **name(s) be added to the rolls; and**

16 **WHEREAS, the Tohono O'odham Council has reviewed the recommendations of**
17 **the Enrollment Committee and approves thereof.**

18 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that, subject**
19 **to the approval of the Secretary of the Interior, the name(s) of the**
20 **following person(s) be added to the official census rolls of the Sells,**
21 **Gila Bend or San Xavier Reservation to wit:**
