

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Tohono O'odham Nation Early Childhood Tribal Subsidy Modification  
October 01, 1997- September 30, 1998)**

**RESOLUTION NO. 98-132**

**WHEREAS, the Tohono O'odham Nation has operated an Early Childhood Program to provide and serve Educational and Preschool learning experiences for children 3-5; and**

**WHEREAS, the Tohono O'odham Nation has provided funding for the continued operation of the Early Childhood Program; and**

**WHEREAS, the Early Childhood Head Start has prepared a budget modification to provide services for children and to ensure the health, safety and appropriate learning experiences for the children it serves.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby approve the Early Childhood Tribal Subsidy Modification in the amount of \$428,495.61. The duration of the budget will be October 01, 1997 thru September 30, 1998.**


**BE FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's officials, to wit; the Chairman, Vice Chairman and any designated official are hereby authorized to negotiate and execute the contract, provided however, that any amendments affecting the funding or funding levels of this contract shall be submitted for further prior approval by this Council.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 14TH, day of APRIL, 1998 at a meeting at which a quorum was present with a vote of 1,766.0 FOR; -0- AGAINST; -0- NOT VOTING; and 161.0 [03] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
