

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 1997 Division of Alcoholism & Substance Abuse Rehabilitation
Aftercare Program Budget Modification Number One)**

RESOLUTION NO. 98-135

WHEREAS, the Tohono O'odham Nation Department of Human Services is presently operating the Rehabilitation Aftercare Program Component under P.L. 93-638 Master Health Contract with the Public Health, Indian Health Services; and

WHEREAS, the Grants and Contracts Office has notified the Division of Alcoholism & Substance Abuse Program of carry over funds available for obligation under FY98 Master Health contract; and

WHEREAS, a budget modification has been prepared for review and approval by the Division of Alcoholism & Substance Abuse to utilize \$8,541.00 of the contract carryover amount to cover expenditures.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:

- 1. It hereby approves and authorizes the modification in accordance with the attached budget.**
- 2. The Tohono O'odham Nation's Officials to wit: the Chairman and Vice Chairman and any designated official are hereby authorized to negotiate and execute the contract.**


The foregoing Resolution was passed by the Tohono O'odham Council on the 14TH day of APRIL, 1998 at a meeting at which a quorum was present with a vote of 1,766.0 FOR; -0- AGAINST; -0- NOT VOTING; and 161.0 [03] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


