1 2 LEGISLATIVE ORDER NO. 98-144 3 WHEREAS, the Legislative Council by Resolution No. 96-063 did adopt the Tohono 4 O'odham Nation Travel Policy; and 5 WHEREAS, the Legislative Council by Legislative Order No. 96-064 further directed 6 the Rules Committee to develop an internal travel policy for the 7 Legislative Branch to govern travel by Council Members, Officers and 8 Staff: and 9 WHEREAS, the Rules Committee, in conjunction with the Legislative Officers, have 10 amended the current travel policy for the Legislative Branch for 11 consideration and adoption by the Legislative Council; and 12 WHEREAS, the amended travel policy reflects changes to the number of committee 13 members allowed for in-state-travel and out-of-state travel based on 14 the need for meeting quorums and budgetary control. 15 NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council 16 that it hereby approves the adoption of the Amended Legislative 17 **Branch Travel Policy.** 18 The foregoing Legislative Order was passed by the Tohono O'odham Council on the 19 16TH, day of APRIL, 1998 at a meeting at which a quorum was present with a vote of 1,413,0 FOR; 353.0 AGAINST; -0- NOT VOTING; and 161.0 [05] ABSENT, pursuant to the 20 powers vested in the Council by Section 1 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 21 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs **22** (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). 23 TOHONO O'ODHAM LEGISLATIVE COUNCIL 24 25 Dennis Ramon, Legislative Chairman 26 ATTEST: 27 28
