

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval for funding from the Children's Justice Task Force Grant)**

RESOLUTION NO. 98-152

WHEREAS, the Indian Child Protection and Family Violence Prevention Act of 1990, 25 USC §§ 320 et seq., authorizes the use of multi-disciplinary teams to address the many issues in child abuse and neglect cases; and

WHEREAS, efforts have been made within the Tohono O'odham Nation to establish such a team; and

WHEREAS, these efforts have been made using existing personnel and have not been successful due to staffing and funding constraints; and

WHEREAS, each of the agencies participating on the team is committed to working cooperatively; and

WHEREAS, the Children Justice Task Force has offered \$15,000 to support a consultant contract for a qualified individual to design and develop a protocol for our multi-disciplinary team.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council:

- 1. Approves the funding from the Children Justice Task Force for a consultant contract to develop a protocol for the multi-disciplinary team.**
- 2. The Tohono O'odham Nation's officials to wit: the Chairman and Vice Chairman and any designated official are hereby authorized to negotiate and execute the grant, and to expend such funds when received.**

The foregoing Resolution was passed by the Tohono O'odham Council on the 17TH, day of APRIL, 1998 at a meeting at which a quorum was present with a vote of 1,813.0 FOR; -0- AGAINST; -0- NOT VOTING; and 114.0 [05] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




