

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Appointing David Garcia to the Arizona/Sonora Commission)**

**RESOLUTION NO. 98-155**

**WHEREAS, the Tohono O'odham Nation is along the US/Mexican Border which consists of 75 miles; and**

**WHEREAS, the Tohono O'odham Nation has always been concerned on border issues along the border; and**

**WHEREAS, an invitation has been received from the Arizona/Sonora Commission for a Representative from the Tohono O'odham Nation to be a member of this committee on border issues; and**

**WHEREAS, the Domestic Affairs and Cultural Committee have reviewed the invitation and recommend that Councilman David Garcia represent the Tohono O'odham Nation.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council appoints David Garcia to represent the Tohono O'odham Nation on the Arizona/Sonora Commission.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 17TH day of APRIL, 1998 at a meeting at which a quorum was present with a vote of 1,126.0 FOR; 71.0 AGAINST; 616.0 NOT VOTING; and 114.0 [05] ABSENT, pursuant to the powers vested in the Council by Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
