

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(FY 1999 Elderly Title III Grant - July 01, 1998 to June 30, 1999)**

**RESOLUTION NO. 98-159**

**WHEREAS, the Tohono O'odham Nation has successfully operated a program for the Elderly members of the Nation; and**

**WHEREAS, funding for the operation of the Elderly Program has been made possible in part by Title III of the Older American's Act of 1965 as amended; and**

**WHEREAS, there are available funds for 1999 through Title III grants with the Inter Tribal Council of Arizona and that the term of this grant shall commence on July 01, 1998 and end on June 30, 1999, for review and approval.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby approves and authorizes expenditures in accordance with the attached budget.**

**BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's Officials to wit: the Chairman, Vice Chairman and any designated official are hereby authorized to negotiate and execute the grant and expend funds.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 24TH day of APRIL, 1998 at a meeting at which a quorum was present with a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**




