RESOLUTION NO. 98-160

**WHEREAS, the Tohono O'odham Nation is presently operating the Family
Preservation Program under FY1998 P.L. 93-638 contract with the
Bureau of Indian Affairs; and**

**WHEREAS, the Bureau of Indian Affairs has allocated additional funds to the
Tohono O'odham Nation in the amount of \$1,600.00 for FY 1998
budget; and**

**WHEREAS, a budget modification has been submitted for review an approval by
the Tohono O'odham Department of Human Services - Division of
Child Welfare Services - Family Preservation Program.**

NOW, THEREFORE, BE IT RESOLVED:

- 1. That the Tohono O'odham Legislative Council does hereby
authorize the expenditures of these funds according to the
attached budget modification for the Family Preservation
Program;**
- 2. That the Tohono O'odham Nation, to wit, the Chairman and Vice
Chairman and any designated Official are hereby authorized to
negotiate and execute the contract.**


**The foregoing Resolution was passed by the Tohono O'odham Council on the 24TH
day of APRIL, 1998 at a meeting at which a quorum was present with a vote of
1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers
vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono
O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and
approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on
March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


