

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Supporting and Approving the Tohono O'Odham Wellness Conference
Budget Modification #1)**

RESOLUTION NO. 98-165

WHEREAS, the Tohono O'Odham Wellness Conference has brought forth a budget modification to its 1997-98 budget; and

WHEREAS, the budget modification reflects subtracted amount of \$4,000.00 from line item 720 Supplies-Office to be added to new line item 750 Capital Equipment/Purchasing in the amount of \$4,000.00; and

WHEREAS, the budget modification reflects subtracted amount of \$866.20 from line item 606 Travel Expense to be added to line item 860 Special Activities; and

WHEREAS, the Health and Human Services and Budget & Finance Committees have reviewed the Tohono O'Odham Wellness Budget Modification #1 and recommends approval.


NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council approves Budget Modification #1 to support the Second Annual Tohono O'Odham Wellness Conference.

BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council recognizes the appropriation of funds to the Wellness 98 Conference will be reimbursed to the Tohono O'odham Nation if it meets the criteria of the O'odham Charitable Organization as approved by Initiative IN-01-97.

The foregoing Resolution was passed by the Tohono O'odham Council on the 24TH day of APRIL, 1998 at a meeting at which a quorum was present with a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




