

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Budget Proposal for the Miss Tohono O'odham Nation
Committee's Revenue/Donations Account and Authorizing
Expenditure)**

RESOLUTION NO. 98-170

WHEREAS, the Tohono O'odham Legislative Council and the Executive Branch recognizes that there are existing funds which have accumulated from October 7, 1994 to April 23, 1997 in the Miss Tohono O'odham Nation Committee's Revenue/Donation account (44-9015); and

WHEREAS, the total amount in the Miss Tohono O'odham Nation Committee's Revenue/Donation account is \$1,272.22, according to information received from the Nation's Accounting Department; and

WHEREAS, the Executive Review Committee, the Human Resources Development Committee and the Budget and Finance Committee have reviewed and approved the Budget Proposal and Justification for the Miss Tohono O'odham Nation Committee's Revenue/Donation account (44-9015) and recommend approval by the Legislative Council.

NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. The Tohono O'Odham Legislative Council approves the Miss Tohono O'odham Nation Committee Budget Proposal and Justification for the Revenue/Donations Account (44-9015).**
- 2. The Tohono O'odham Legislative Council authorizes expenditure of the funds from Account No. 44-9015 and any funds received from sponsors, donors and sales in accordance with the budget. Such funds are to be available until expended.**


The foregoing Resolution was passed by the Tohono O'odham Council on the 24TH, day of APRIL, 1998 at a meeting at which a quorum was present with a vote of 1,854.0 FOR; -0- AGAINST; 73.0 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).






