

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Modification of the Credit and Finance Program Budget  
Funded through Federal Contract 1450CTH54T61071)**

**RESOLUTION NO. 98-176**

**WHEREAS, the Legislative Council of the Tohono O'odham Nation approved a FY  
1998 budget in the amount of \$203,200 for the Credit and Finance  
Program; and**

**WHEREAS, funds in the amount of \$217,580 have been provided by the Federal  
Government for this program; and**

**WHEREAS, savings of budgeted funds have occurred in personnel-related line  
items; and**

**WHEREAS, the Program wishes to modify its program operations to expand and  
provide new services to its clients; and**

**WHEREAS, the Credit and Finance Program has submitted a request to modify its  
budget that distributes the additional funds, and the savings into  
operating and capital budget line items to support these changes.**

**NOW, THEREFORE, BE IT RESOLVED by the Legislative Council of the Tohono  
O'Odham Nation that Modification One to the Credit and Finance  
Federal Budget is approved.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 04TH  
day of MAY, 1998 at a meeting at which a quorum was present with a vote of 1,766.0  
FOR; -0- AGAINST; 161.0 NOT VOTING; and [04] ABSENT, pursuant to the powers  
vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono  
O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and  
approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on  
March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
