

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Correcting Resolution No. 98-169, "Authority for the Administration for Native  
Americans Grant Proposal for Governance - Land Use Planning")**

**RESOLUTION NO. 98-178**


**WHEREAS, the Tohono O'odham Legislative Council approved Resolution No. 98-169 as presented; and**

**WHEREAS, the first year project cost and the total amount was miscalculated by \$3,000.**


**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Nation Legislative Council hereby amends Resolution No. 98-169 to reflect the actual cost of the Land Use Planning Process Project; a Three Year Project in the amount of \$394,384.54 for Year One, \$388,588.08 for Year Two, and \$387,845.65 for Year Three for a total amount of \$1,170,818.27.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 4TH day of MAY, 1998 at a meeting at which a quorum was present with a vote of 1,605.0 FOR; -0- AGAINST; 322.0 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


