

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Supporting the submittal of the JTPA/NEW Comprehensive Annual Plan for
1998 to the U.S. Department of Labor)**

RESOLUTION NO. 98-191

WHEREAS, the Tohono O'odham Nation JTPA/NEW program has received instructions for the submittal of the 1998 Comprehensive Annual Plan to the U.S. Department of Labor for the period beginning July 1, 1998 through June 30, 1999; and

WHEREAS, the Tohono O'odham Nation is eligible for funding in the amount of \$459,405.00; and

WHEREAS, the deadline for submittal of the plan is May 8, 1998.

NOW, THEREFORE, BE IT RESOLVED, that the Tohono O'odham Legislative Council does hereby approve the submittal of the Tohono O'odham Nation's Title IVA Comprehensive Annual Plan for 1998.

BE IT FURTHER RESOLVED that the JTPA/NEW program will submit the finalized plan along with a budget upon completion of committee reviews and approvals.

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation Officials, to wit; the Chairman and any designated official are hereby authorized to negotiate and execute the contract, provided however, that any amendment affecting the funding or funding levels of this contract shall be submitted for further prior approval by this council.

The foregoing Resolution was passed by the Tohono O'odham Council on the 08TH day of MAY, 1998 at a meeting at which a quorum was present with a vote of 1,785.0 FOR; -0- AGAINST; -0- NOT VOTING; and 142.0 [05] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(1), (2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
