

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Request from the TERO Commission to draft and present a Prevailing Wage
Law Ordinance for the approval of the Tohono O'odham Nation)**

RESOLUTION NO. 98-196

**WHEREAS, pursuant to the TERO Ordinance No. 01-85, there is created a Tribal
Employment Rights Commission; and**

WHEREAS, the TERO Commission is provided certain powers; and

**WHEREAS, the TERO Commission does not have statutory authority to establish
and enforce prevailing wage rates by regulation within the Nation; and**

**WHEREAS, the TERO Commission is now requesting authorization from the
Tohono O'odham Legislative Council to grant the TERO Commission
authority to draft and present a Prevailing Wage Law Ordinance in
consultation with the Judiciary Committee of the Council for
presentation at its next legislative session.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council
now grants authority to the TERO Commission to draft and present a
Prevailing Wage Law Ordinance in consultation with the Judiciary
Committee of the Council at the next Legislative General Session.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 08TH
day of MAY, 1998 at a meeting at which a quorum was present with a vote of 1,785.0
FOR; -0- AGAINST; -0- NOT VOTING; and 142.0 [06] ABSENT, pursuant to the powers
vested in the Council by Section 1 (I) of Article VI of the Constitution of the Tohono
O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and
approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on
March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
