

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'odham Division of Senior Services - FY 1998 Elderly Title C-1
Modification #2, July 01, 1997 - June 30, 1998)**

RESOLUTION NO. 98-197

WHEREAS, the Tohono O'odham Nation Executive and Legislative Council recognize the need for improved services to O'odham elderly; and

WHEREAS, the Tohono O'odham Nation operates a program for the elderly members of the Nation; and

WHEREAS, the Inter-Tribal Council on Aging has approved and granted one time only Title III Older American Act funding in the amount of \$8,000 for purchase of kitchen equipment and Title III building sites renovation and repair; and

WHEREAS, the one time only funds must be encumbered by June 30, 1998.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby:

- 1. Approves the incorporation of funds into Account 13-1422 for Capital Equipment and other equipment for the purchase of needed kitchen supplies and building renovations.**
- 2. Approves and authorizes expenditures in accordance with the proposed budget.**

BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's Officials to wit: the Chairman, Vice Chairman and any designated official are hereby authorized to negotiate and execute the grant and expend funds.

The foregoing Resolution was passed by the Tohono O'odham Council on the 08TH. day of MAY, 1998 at a meeting at which a quorum was present with a vote of 1,595.0 FOR; -0- AGAINST; -0- NOT VOTING; and 322.0 [05] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
