**RESOLUTION NO. 98-198**

**WHEREAS, the Constitution of the Tohono O'odham Nation under the Preamble to provide welfare of present and future generations of our people; and**

**WHEREAS, under Article I, Jurisdiction Section 3 Sovereign Powers, Authority and Jurisdiction of the Tohono O'odham Nation and its Government over members of the Tohono O'odham Nation shall extend beyond the geographical boundaries of the Tohono O'odham Nation; and**

**WHEREAS, there are nearly 2,000 enrolled members that reside in Mexico; and**

**WHEREAS, there is needed health care services for the O'odham in Mexico; and**

**WHEREAS, the Domestic Affairs, Health & Human Services, Cultural Resources, and Budget & Finance Committees have reviewed the proposal and recommend for approval.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby supports and appropriates \$119,865.00 for the O'odham in Mexico Transportation Services.**

**BE IT FURTHER RESOLVED that funding in the amount of \$119,865.00 be appropriated from the General Revenue Account.**

**BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council recognizes the appropriation of funds for the O'odham in Mexico Transportation Services will be reimbursed to the Tohono O'odham Nation if it meets the criteria of the O'odham Charitable Organization as approved by Initiative IN-01-97.**


The foregoing Resolution was passed by the Tohono O'odham Council on the 08TH day of MAY, 1998 at a meeting at which a quorum was present with a vote of 1,304.0 FOR; -0- AGAINST; 234.0 NOT VOTING; and 332.0 [05] ABSENT, pursuant to the powers vested in the Council by Section 1(c)(2) & (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
