

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 98 Limited Attorney Contract for David Braun to Serve as
a Limited Conflict Attorney)**

RESOLUTION NO. 98-201

WHEREAS, there are no other conflict attorneys to handle conflicts which the Nation's Advocate Program is not ethically allowed to handle in the increasing needs of tribal members for legal representation in civil and criminal matters; and

WHEREAS, the Advocate Program wishes to retain David Braun to be appointed to represent a client with conflicts of interest who can not be represented by the Nation's Advocate Program and the Advocate Program's three conflict attorneys, therefore the Limited Conflict Attorney Contract is being requested; and

WHEREAS, the Advocate Program wishes to retain David Braun as a Limited Conflict Attorney until the conclusion of a case within the Tohono O'odham Judicial Court; and

WHEREAS, the Advocate Program has presented a limited contract for David Braun which confirms and ratifies the terms and conditions related to future services, a copy of which is attached; and

WHEREAS, the Domestic Affairs Committee recommends approval by the Legislative Council of a Limited Attorney Contract with David Braun on such terms.

NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. The Legislative Council ratifies and approves the Limited Conflict Attorney Contract for David Braun in the form attached hereto, until the conclusion of a case within the Tohono O'odham Judicial Court and not to exceed \$3,000.00.**


2. Funding for the Limited Conflict Attorney Contract for David Braun shall be provided under the operating budget of the Advocate Program for Fiscal Year 1998.
