(Approval of Tohono O'odham Department of Human Services -Division
of Psychological Services - FY 98 Tribal Budget Modification #2)**

RESOLUTION NO. 98-216

**WHEREAS, the Tohono O'odham Nation is presently operating the Tohono
O'odham Psychological Services through a P.L. 93-638 grant and
Tribal funding; and**

**WHEREAS, the Tohono O'odham Nation Human Resources has completed a
reclassification of the Systems Analyst position; and**

**WHEREAS, the program has realized savings of \$52,292.18 due to the vacancy of
the Systems Analyst position since November 1997 and Clinical
Director position from December 1997; and**

**WHEREAS, the Psychological Services Division has produced a budget spending
the savings due to vacancy to fund operational expenses and to
purchase necessary office furniture and computer equipment.**

NOW, THEREFORE, BE IT RESOLVED:

- 1. That the Tohono O'odham Legislative Council hereby approves the
attached FY 1998 Psychological Services Tribal Modification #2.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 02ND,
day of JUNE, 1998 at a meeting at which a quorum was present with a vote of 1,927.0
FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested
in the Council by Section 1(d)(3) of Article VI of the Constitution of the Tohono
O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and
approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on
March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**




