

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Ratifying Tribal Elders Home Adaptation and Renovation Project Contract  
Between Tohono O'odham Nation and Indian Oasis Baboquivari Unified  
School District and Jerry Carlyle)**

**RESOLUTION NO. 98-220**

**WHEREAS, pursuant to resolution numbers 98-151 and 98-219 the Legislative Council approved and authorized expenditure of the Tribal Elder Home Adaptation and Renovation Project (TEHARP) to enable elders to remain in their homes with dignity and in reasonable comfort for as long as possible; and**

**WHEREAS, in order to obligate funds a contract was signed between Tohono O'odham Nation, and the Indian Oasis Baboquivari Unified School District and Jerry Carlyle.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council:**

- 1. Review and approves the signed professional service contract between the Tohono O'odham Nation and Indian Oasis Baboquivari Unified School District and Jerry Carlyle.**
- 2. The Tohono O'odham Nation's Officials to wit; the Chairman and any designated official are hereby authorized to negotiate and execute the contract and expend such funds when received.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 02ND day of JUNE, 1998 at a meeting at which a quorum was present with a vote of 1,761.0 FOR; 95.0 AGAINST; 71.0 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
