**RESOLUTION NO. 98-222**

**WHEREAS, the Tohono O'odham Legislative Council has received a request for support and monetary assistance from Sunnyside High School for the participation of Anthony Francisco for track activities: Golden West Invitational in Sacramento California on June 12-14, 1998 and the Jr. Nationals in Edwardsville Illinois on June 25-29, 1998; and**

**WHEREAS, the total amount of \$2,039.00 is being requested to cover airfare, lodging, and meals for the above scheduled events; and**

**WHEREAS, the Legislative Council is in support of promotion activities for our O'odham youth and recognizes the positive gains attained by our youth through such activities; and**

**WHEREAS, the Tohono O'odham Legislative Council recognizes that an additional amount of \$2,961 be included for future expenses for a total contribution of \$5,000.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby makes a monetary donation in the amount of \$5,000 for travel expenses for Anthony Francisco.**

**BE IT FURTHER RESOLVED that travel expenses in the amount of \$5,000 shall be appropriated from the General Revenue Account.**

**BE IT FURTHER RESOLVED that the participant will provide a report to the Legislative Council during the July General Session.**

**chaperone for participation in the National track activities will be reimbursed to the Tohono O'odham Nation if it meets the criteria of the O'odham Charitable Organization as approved by IN-01-97.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 03RD day of JUNE, 1998 at a meeting at which a quorum was present with a vote of 1,766.0 FOR; -0- AGAINST; -0- NOT VOTING; and 161.0 [03] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


